Motion by Schworm and support by Mouser to approve ZOA 20-007 REMOVING OVERLAY DISTRICTS and send it to the Township Board. It includes removing, from the Table of Regulations, Planned Commercial District, Office District and Gateway Commercial District. Carried with a vote of 6-0.
